


## **TIMELINE**

### **IMPORTANT DATES AT A GLANCE**

31.05.2019: Call 3 for applications opens

30.08.2019: Application deadline for call 3

29.10.2019: Results of written application evaluation

18.11. – 6.12.2019: Interviews

16.12.2019: Final results and attribution of fellowships

23.12.2019: Deadline for the acceptation of fellowships

01.03.2020 -28.02.2022: Estimated period of Fellowship 3

#### **CALL DATES AND SUBMISSION DEADLINES**

The call for proposals opens on May 31<sup>st</sup> 2019 and closes on August 30<sup>th</sup> (midnight). Should documents be missing applicants will be asked to complete their application, typically within 5 working days.

### **SCHEDULE FOR THE SELECTION PROCESS**

The eligibility and ethical issues check will be carried out in the first half of September, followed by the evaluation of the written applications until the end of October. Selected candidates will be invited to the interviews until mid-November; and the interviews will take place in the second half of November and the first week of December. Applicants will be informed if their application has been successful in mid-December. The recruitment process takes part from then until approximately the end of February, with the first possible starting date of the fellowship on March 1<sup>st</sup> 2020 or upon agreement.
